WITHDRAWAL POLICY

Class 1:

The \$300 deposit is non-refundable. However, if you withdraw from Class 1 BEFORE it has started, Innersource will refund you the \$300.

For withdrawals that occur from Class 2 forward:

If you withdraw from the program more than thirty days before the start of Class 2, 3 or 4, you will receive a 50% refund on any monies you have paid toward that particular class, and a 100% refund of money for any classes you have paid for thereafter. The \$300 deposit is not part of this refund as it is non-refundable. If you withdraw less than thirty days prior to the start of class, no refund of tuition for that class. If you just miss a class, but intend on completing the one-year program, you are still responsible for the full tuition for the class missed. Your tuition will still give you access to one of the teachers for questions on the material as well as Course Books and continued participation in Level 1: Fundamentals.

Withdrawals must be received in writing or by e-mail (sarahlpowen@gmail.com) and will be promptly acknowledged once received. In the case of emergencies (death or injury) or catastrophic (natural or accidental) events, you may contact Sarah Owen MS LPC and discuss your options.

MISSED CLASS POLICY

It is your responsibility as a student to make up all work and instruction you miss if you fail to attend any of the four classes in this Level 1: Fundamentals program. Every effort will be made to work with you, including options such as review classes and private tutorials, at the student's expense.
